Nearly a quarter of young people in care are over the age of 16. However, there are limited high-quality options for accommodating these young people in safe, appropriate places. Supported lodgings is a provision for young people whereby they live in the home of a 'host' family, individual or couple. Home for Good works to raise awareness of this unique opportunity and journey with pioneering individuals, couples and families as they explore becoming hosts.



FAMILIES ON THE EDGE OF CARE

The families that we work with often face multiple challenges and struggle to cope. Families

benefit from being seen, heard and understood by Safe Families volunteers. Our hope is that families can reach their potential, feel empowered, and that through support they are able to provide safe and nurturing homes for their children.



Eric and Wendy are a remarkable couple from Lincolnshire who began volunteering for Safe Families eight years ago.

Since then, Eric and Wendy have always been supporting at least one family and have amazingly brought hope and belonging to over 30 families facing crises.

They have provided 100 bed nights on 56 different occasions to 13 children between the ages of 0 to 14.

LEAVING A GIFT IN YOUR WILL

OUR TIPS TO HELP YOU WRITE YOUR WILL



Writing your will can seem like a daunting process. Below we have shared some simple tips to make this journey easier:

List everything you own

Your assets include any real estate or land you possess, as well as accounts with banks or building societies, savings, investments, business interests, pensions, insurance plans, and valuable items like vehicles and jewellery.

2 Work out what you owe

Your liabilities consist of any unpaid mortgage or rent, car financing arrangements, credit card balances, bank loans, or other personal debts you may owe.

Work out the value of your estate

To determine the value of your estate, deduct your liabilities from the total worth of your assets. This amount will cover your funeral expenses, taxes, and any bequests specified in your Will.

Decide who you'd like to provide for

Clearly identify the individuals and organisations you wish to support, ensuring you include their full names and addresses for easy identification.

Who will take care of your dependants?

If you have dependents such as children, relatives, or pets, indicate who you want to care for them and how their care will be financed.

6 See a qualified legal adviser

A knowledgeable Wills and Trusts solicitor, or a specialist team at your bank or building society, can assist you in evaluating your responsibilities and choices. If you don't have a solicitor in mind, consider using our **Free Will-Writing Service**.

7 Choose someone to carry out your wishes

Your executors can be either legal professionals or trusted friends and relatives. Ensure they are willing to accept this responsibility before you appoint them.

8 Check your draft will carefully

When your adviser provides you with the draft of your Will, review it thoroughly. If you notice any errors, have questions, or wish to make changes, don't hesitate to speak up.

Signing and witnessing your will

You must sign and date your Will in the presence of two witnesses. The witnesses must be over 18, independent, and neither they nor their spouses or civil partners can be beneficiaries of the Will.

Keep your will somewhere safe

Store your Will securely and inform your executors of its location. Keeping your Will, alongside other important documents, making things easier for your executors when the time comes.

YOUR SUPPORT CAN HELP PARENTS LIKE SIMON AND SUE

Meet Sue and Simon, devoted foster carers to a boy who has experienced significant trauma and challenge in his young life, which affects his behaviours and the way he sees the world.

They deeply love the boy in their care, but were struggling to cope with the demands of looking after a child who had experienced early trauma.

A friend from church introduced them to Home for Good who wrapped around their famly with different types of support, so that their family could continue to flourish.

They were connected with Judith from our enquiry and family care team, who was able to offer expertise as well as a prayerful listening ear.

Sue shared, "With no social worker assigned to us for the first 14 weeks of this placement, and Simon working full time, the support I received from Judith was crucial."

Simon and Sue also connected with a local Home for Good peer support group, where they made connections with others going through the same challenges.

"Chatting to Judith and getting along to the group when possible has been so helpful. Finding people who have been through what



we are experiencing – people who 'get you' – is such a blessing and helps us feel we are not alone."

Mike, part of the church engagement team at Home for Good, visited Simon and Sue's church, and helped them to think through the challenges they face and how the church could support them.

Each of these three types of support have given Simon and Sue a community around them who they can lean on, allowing them to continue to provide a nurturing home for their young boy.
